University of Puerto Rico Technology Fund Policy

The University of Puerto Rico (UPR) Technology Fee Policy establishes a fee payable for each enrollment period, intended to finance technology expenses that complement the teaching and learning experience.

Policy Details

Technology Fund

Fee funds are deposited into the UPR Technology Fund, created to cover technology expenses.

Fee Purposes

The fee may be used to:

- Acquire software and licenses for student use on computers, local infrastructure, or online services.
- Acquire or improve local computing and communications infrastructure for student use.
- Improve technological resources that enrich and facilitate teaching and learning in the classroom.



Certification 70 (2004-2005)

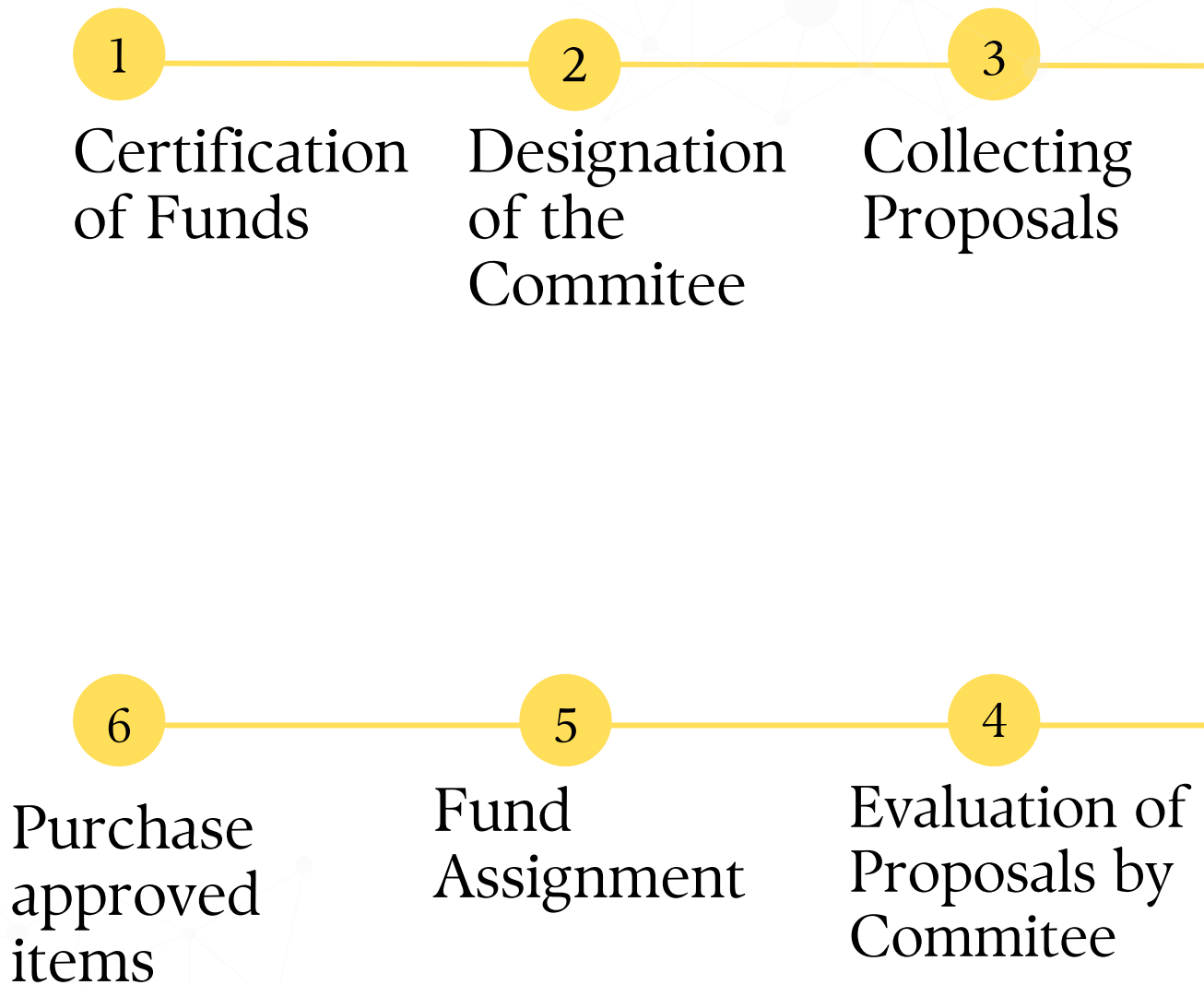
The Certification 70 (2004-2005) of the UPR Board of Trustees establishes the technology fee. The policy applies to all UPR campuses.

The fee is used to fund technology expenses that complement the teaching and learning experience.

The Technology Fee is payable for each enrollment period. The fee shall be used to cover expenses for this purpose, in accordance with the regulations to be established by the President of the University for such purposes.
